Secretary's Report 2015-16

The Holidays In the financial year 2015-16 we have provided a record **16 weeks** of holidays at the Nightingale Centre, Great Hucklow for children from Mansfield, Nottingham, Manchester, Birmingham, Accrington (2 groups, one of them a new group), Southend-on-Sea, and Rotherham, and groups from Liverpool. This probably represents a natural top limit. It may be necessary to cut back this number slightly for 2017.

Responses from the groups, leaders and children are positive and underline the value of the breaks we provide. Particular plaudits were offered to the Andrews coach drivers. As is often the case we have received a number of donations from visiting groups to the Centre alongside SACH weeks. There are sometimes difficulties, not insurmountable, which are nevertheless illustrative of the need for high-quality commitment and sensibility from leaders in organisations themselves under pressure.

Our **Fund-raising** again has held up, donations having increased on last year's slightly lower total. However, as noted last year, we are coming to the end of certain regular donations. We again applaud the variety of ways in which folk raise money for us. Derek Smith's Service is still available for congregational use in a special SACH Service. Some lay folk kindly donate their Preaching Fees. I can still travel with my "SACH History Slideshow" Service: all my preaching fee on these occasions goes to SACH.

At the time of writing Send a Child is actively exploring the pros and cons of converting to CIO (Charitable Incorporated Organisation) status.

At the **Unitarian General Assembly meetings**, we again had our Stall, featuring Dr Judith Short's artistic "bookfold" creations to be made to order, and we auctioned a cricket ball signed by Joe Root. We raised some £240. *GA Zette* offered us the usual helpful plug. Our thanks are again due to our Donations Treasurer-cum-"**fund-chaser**", **Sue Catts (Cooper)** in approaching various Fund-giving bodies both Unitarian and non-Unitarian, as and when an opportunity emerges or presents itself.

We still do need a "**Fund Raiser**" to take this challenging work forward, pursuing contact with trusts and companies which might "work" with us.

Groups of **Visitors to the Centre** itself, Unitarian and non-Unitarian, as mentioned above, again feature in our list of donors: thank you all.

Out and about The Hon. Secretary was delighted to be invited to share a session on SACH at the **Ministers' Conference** at the Centre in September, as part of the theme of "Tender Bridges" - our Unitarian "love in action".

Group Leaders' Gathering A project long in the conceptual eye of Stella Burney, Nightingale Centre manager, finally came to pass earlier this month. About a dozen leaders of SACH groups responded to an invitation, at their own organisations' expense, to the Centre to share ideas, experience, good practice; to hear a presentation from Stella about expectations and aims from the Centre's point of view; suggested activities in line with SACH philosophy; and domestic matters, together with background information from me, including my personal "anecdote" of helping on a SACH week some 40 and more years ago. My personal impression was of a good and mutually helpful atmosphere - and perhaps the dispelling of some myths!

Our warmest **thanks**, as always, go to the many people who have given help to the Fund during the past year: to Centre Manager, Stella Burney; to Mr Russell Andrew (he is the 4th generation in the company!) and the Andrew's coach drivers; the leaders and helpers of all the holidays; the Officers and Trustees of the Fund. Our grateful thanks are due also to the many folk who continue to support us financially, to make possible the continuation of the much appreciated holidays. My personal thanks yet again go fellow officers of the Fund, Chairman, Peter Hewis, the Fund's Treasurer, David Ogden, and Donations Treasurer, Sue Catts.

Thanks to you all, once again over **300 young people** have been able to enjoy the special "Far-off Magic" of Great Hucklow. We know it makes a difference to young lives - "Broadening Horizons".

A personal note Whilst the business of SACH continues as inspiration and motivation, this year I have felt unable to be as proactive as I should like; the old horse is increasingly getting ready to be put out to grass, methinks. Watch out, I am casting round for my successor! As Secretary, I regularly get in my e-mails, invitations to expensive day conferences about government action to combat exploitation of children, and the mental health of students: chastening reminders. We never spend your money on my, or anyone else's, attending such, I hasten to add! I am, rather, gratified to think we offer an essential, if small, practical counter to this abomination in our present society.

Treasurer's Report for the year ended 30th September 2016

As Ernest says in his Secretary's report, we provided a record 16 weeks' holidays in 2015-16. The total cost of the holidays was almost £99,000.

The need for holidays is clear, but we probably cannot sustain this level of activity. Donations were £4,500 higher than last year, at £55,000. Thank you very much to everyone who made a donation.

However, we did have to sell some of our investments as our expenditure exceeded our income by almost £35,000. Using the Charity Commission's method, the figure was approximately £26,000 because we made a profit of £2,500 on the investments that we sold and the value of our remaining investments rose by over £6,000.

We are grateful for all donations. I would, however, like to thank a number of people and organisations: Brethren of Notts Conclave 166, Dagny Raymond Trust, Elliott Masonic Lodge 8569, Joseph & Ann Slater Memorial Fund, the Leonard Chamberlain Trust, Provincial Grand Lodge of Nottinghamshire, Royal Ark Mariners Lodge, South Birmingham Friends Institute Trust and the Zochonis Charitable Trust.

These generous donations from charitable trusts and Masonic lodges added up to £15,000 and I believe there are other groups out there who would make donations if they knew that the Send a Child to Hucklow Fund needed the money. Our recent overspending highlights more than ever the need to find an Appeals Treasurer, who will write to trusts and groups appealing for donations. This can be a tough job, as many groups say "no" or do not even respond, but that makes it all the more satisfying when donations do arrive. If you would like to volunteer, please contact Sue Catts or me.

Some congregations have special collections and invite people to gift aid their donations, we have also had donations in lieu of birthday and Christmas presents and some lay preachers have donated their preaching fees. May I remind you about Easyfundraising? When you shop online, many shops will give a small percentage of the cost to the Fund at no extra cost to you. After a couple of reminders, we actually raised more last year than the year before from Easyfundraising. Text giving has yet to take off, but we will continue to offer it as it does not cost the Fund anything.

We lost a number of supporters this year. We received gifts in memory of a number of them, as can be seen in the special list. Legacies and gifts in memoriam are invested to provide long term income to pay for holidays. However, from time to time, we have to draw on these reserves to cover the deficit on holidays.


My thanks as always to Sue Catts, the Donations Treasurer, and Mike Georgiou, the Auditor.
