Secretary's Report 2016-17

The Holidays In the financial year 2016-17 we have provided **13 weeks** of holidays at the Nightingale Centre, Great Hucklow for children from Mansfield, Manchester, Birmingham, Accrington (2 groups), Southend-on-Sea, a new group from Chesterfield, and groups from Liverpool. We hope we may maintain contact with groups from Rotherham and Nottingham who have worked with us previously. We are working to clarify the ethos of the Fund's holiday provision with parents and school governors of potential new groups.

Responses from the groups, leaders and children once again testify to the value of the holiday breaks we provide. Some of Andrew's coach drivers received particular acclaim for making life interesting with their local knowledge. There were a few challenges along the way, but nothing the evertolerant Nightingale Centre staff couldn't handle.

Our **Fund-raising** has again proved quite amazing, though our Treasurer's provisos need to be noted. Thank you for the various ingenious ways you raise money for us. We hope some of our Unitarian congregations will hold special services, and we can help with ideas for the content. We have Lay Worship Leaders who kindly donate their Preaching Fees. My "SACH History Slideshow" Service is still mobile, for which all my preaching fee goes to SACH.

Becoming a CIO (Charitable Incorporated Organisation). At the November Trustees Meeting the decision was taken to submit, for the Charity Commission's approval, a document prepared in accordance with their guidelines. Our thanks are due to our retiring Chairman, Peter Hewis for preparing the draft for this, and coordinating suggestions from other Trustees; and to Roderick Ramage and Christine Hayhurst for helpful assistance.

At the **Unitarian General Assembly meetings**, our Stall had a somewhat "quiet" year, though we drew particular attention to our "Kit out a Kid for a Rainy Day" Appeal. Delegates received a copy of the Newsletter put together by Colleen Burns, featuring the Appeal, the story of Joe Root's donated cricket ball, and the "give-a-car" scheme. Copies are still available. We had the usual mention in *GA Zette* and raised some £850+ in sales and donations.

Our thanks are again due to our Donations Treasurer-cum-"fund-chaser", **Sue Catts** in approaching various Fund-giving bodies both Unitarian and non-Unitarian, as and when an opportunity arises. We still do need a dedicated Fund Raiser, in particular pursuing contact with trusts and companies which might be sympathetic to us. Groups of visitors to the Nightingale Centre itself, Unitarian and non-Unitarian, again feature in our list of donors: thank you all.

Out and about I confess to having unilaterally imposed a £5 "Ministerial Premium" excess on the minimum fee requested, pointing out that this goes to SACH, whenever I have been preaching "out and about", and am most grateful that so far no congregation has demurred at this!

Our thanks, as always, go to the many people who most directly make the work of the fund happen: Centre Manager, Stella Burney; the staff of Andrew's Coaches; the leaders and helpers on all the holidays; the Officers and Trustees of the Fund. Our thanks are due also to the many folk who continue with financial support, making possible the continuation of the much valued and appreciated holidays.

Old and New Our Chairman, **Peter Hewis**, having exceeded his intended term by one year, now retires from this position, though remaining a Trustee. I thank him personally for wise counsel, support and for being a helpful soundingboard. Completing her time as Donations Treasurer is **Sue Catts**, who has brought us more into the digital age, and good humouredly organised the record of our incoming donations. **John Allerton**, one of our longest-serving people, indicated his wish to resign as a Trustee. He led some of the most challenging SACH weeks back in the late 60s and 70s, was an original signee of the Trust document in 1976, and has been a Trustee ever since. We thank him most warmly for his many contributions over the years. We welcome **Sarah Benfield** as Chair, and **Ruth Taylor** as Donations Treasurer, both having already served as SACH Trustees for a number of years, hoping and trusting they will find satisfaction and joy in exercising their offices.

Thanks to you all, once again over **300 children** have experienced the special "Far-off Magic" which is the Centre and Great Hucklow. Young lives are influenced; money really does buy happiness!!

Personal Reflections

No putting out to grass on the immediate horizon for me just yet it appears! Another year has passed and once again I am heartened as ever by the support folk give to us, and by the comments we get back not least from the children. Treasurer's Report for the year ended 30th September 2017

After sustaining a big loss last year, we reduced the number of holidays we could provide. We arranged thirteen weeks' holidays, at a total cost of £86,000.

As a result, our expenditure exceeded our live income by £17,000. Using the Charity Commission's method, the figure was only just over £4,000 as our investments performed well and their value increased by almost £13,000.

Donations were an amazing \pounds 60,000. Thank you to everyone who contributed. This figure includes the final instalment of the \pounds 50,000 matching donation from our 50th anniversary appeal.

We also received two legacies: £60,000 from Thomas Whitehead and £3,000 from Mary Burns. We have used this money to replenish our reserves, from which we had been drawing heavily in recent years.

We are grateful for all donations. I would, however, like to mention a number of people, organisations and events. These are: the Merseyside and District Missionary Association (MDMA); the Secret Monitor Conclave (Masons); Dagny Raymond Charitable Trust; Mansfield Lodge of Freemasons; the Yorkshire Unitarian Union; Southern Unitarian Association; James Henry Blake's Charity; Elliott Lodge of Freemasons; St Peter's Mark Lodge No. 1513; Ashfield Royal Arch Chapter No. 2412; Cheshire Freemasons Charity; Great Hucklow Community Spirit; Whitegates Children's Trust; the Joseph & Ann Slater Memorial Fund; Midland Unitarian Association; NELUM; and Brandwood Lodge No. 7679.

Happy 60th birthday to David Burton, whose family and friends donated £2,500!

Some of our churches are also able to make substantial donations; these include Westborough Chapel Scarborough; the Octagon Chapel, Norwich; Dunham Rd Chapel, Altrincham; Kingswood Meeting House; and Dean Row Unitarian Chapel.

Many of the donations from charitable trusts come because of Sue Catts's continued requests for donations, which she has been persevering with in addition to her role as Donations Treasurer. I will miss her efficiency and generosity with her time when she hands over this responsibility.

We are delighted that Ruth Taylor has agreed to be our new Donations Treasurer. We would very much like to find an Appeals Treasurer, who will write to trusts and groups appealing for donations. This can be a tough job, as many groups say "no" or do not even respond, but that makes it all the more satisfying when donations do arrive. If you would like to volunteer, please contact me. With Christmas approaching, don't forget to route your online shopping via Easyfundraising. When you shop online, many shops will give a small percentage of the cost to the Fund at no extra cost to you. You can also make donations online via Virgin Money Giving, or by direct bank transfer.

We try to keep costs under control but there are increasing costs of administration. CAFBank now charges us £5 a month to look after our money and pays no interest. As we own shares, the Fund will have to register with the London Stock Exchange under the latest anti-money-laundering directive. That will probably cost £150 per year.

As well as thanking Sue Catts, I would like to thank Mike Georgiou for reviewing the accounts once again.

Finally, I would like to propose that we keep our fundraising target at £50,000 for the next year. As we have received all of our 50th anniversary matching donations, it will be more difficult, but the need is as great as ever and I am sure we can rise to the challenge once again.
